Repeat prescriptions of anticoagulants should only be issued if the prescriber has checked that the patient is regularly attending the anticoagulant clinic, that the INR test result is within safe. Patients on certain medication can not receive a repeat prescription without seeing the doctor. eg warfarin, methotrexate etc. Sep 22, - The repeat prescription request for warfarin caught my eye as I was going through the bundle. Review overdue. I opened up the record to check out the details: year-old man, five years post-op, mitral valve replacement, on warfarin. I reviewed the blood test results: not had INR checked for five months. Nov 8, - I order repeat prescriptions online. It works very well. The pharmacist often asks me about my INR. I'm not sure they need to do that, I think it's down to everyone who takes warfarin to take personal responsibility for their INR. What would really help is an education programme to go through treating yourself. (2) When you bring your blood test result to the surgery please request a repeat prescription for Warfarin, ie at the same time, unless you think that you will not need any more tablets until your next blood test is due. We will try to have your prescription ready within two working days, so long as we have your latest blood test.
