An article in Business Day yesterday about a federal court decision that upheld the patent on Plavix, a blood thinner marketed by Bristol-Myers Squibb and Sanofi-Aventis, misstated the potential financial damages that the Canadian drug maker Apotex might have to pay the companies for selling a generic version last year. A federal district judge in Manhattan upheld the patent on the anti-clotting drug Plavix yesterday, removing a weighty uncertainty for Bristol-Myers Squibb and Sanofi-Aventis, the companies that market the widely used product. The agreement to limit damages was one of the considerations that prompted Apotex to ship its product last year. In addition to upholding the Plavix patent, Judge Stein prohibited the generic-drug producer Apotex from selling its copy of the drug in the United States. Bayer HealthCare Pharmaceuticals Inc.
