The term over-the-counter may be somewhat counterintuitive , since, in many countries, these drugs are often placed on shelves in self-service areas of stores, like any other packaged products. A drug that is UAD can also be sold at drugstores, stores where no prescription can be filed and there is only a relatively small selection of popular drugs like painkillers and cough medicine. Regulations detailing the establishments where drugs may be sold, who is authorized to dispense them, and whether a prescription is required vary considerably from country to country.
