By Han Feng, Pharm. Refills of hydrocodone combination products will require a new prescription for each refill. What if I still have refills left on my previously written prescription? If your current prescription was written more than six months ago or was refilled more than five times, a new prescription will be required. If your current prescription is more than six months old or has been refilled more than five times, a new prescription will be needed. Have you heard about recent changes related to the regulation of certain prescription painkillers? If aspirin is taken at high doses and for a long time, it can slowly damage this layer. What is a controlled substance? It is important that you talk with your doctor about Tramadol so you can learn as much as possible about it before taking it. It was previously believed that Tramadol posed less of a risk for abuse, which is why it was only classified as a controlled substance in just three states. There are a lot of serious withdrawal symptoms that can occur when stopping this medication suddenly, so it is therefore crucial that you do not do that. This damage can lead to bleeding. Many states do not allow hydrocodone combination product prescriptions to be called in, faxed, or sent electronically to the pharmacy. Are there any risks to taking aspirin? Prescriptions written prior to October 6 and those that have refills may continue to be filled as written on the original prescription or until April 8, whichever happens first. Not everyone is given the same dosage, and too high of a dosage can be incredibly dangerous. New regulations for dispensing hydrocodone combination products will take effect October 6. The DEA requires that all tramadol prescriptions must be filled according to the new regulations beginning August 18.
