Aug 7, - A copy of the Board resolution can be found at the end of this document. (3) A prescription for an opioid analgesic was issued before the law change went into effect (April 6, ). Do I still have to fill within 14 days of the date issued? No. You would follow the requirements for dispensing opioid analgesic. You can assist your pharmacist and avoid delays by calling your pharmacy a few days before you run out of your medication. Also, in making the decision to refill a prescription, the pharmacist must consider how long the medication should last (based on the directions for use and the quantity dispensed), and may refill it. Apr 24, - There's also a regulation when you fill so many days early you will "technically" have that many extra after 6 months and they could deny it for an extra week. It's BS but mathematically Last time they were out of meds due to shortage of particular prescription, then deliver me after 3 days. This allows me to Know Your Rights at the Pharmacy. Sep 23, - In October , a pharmacist was accused of providing early refills in North Carolina, according to a Consent Order settling the matter. Among the findings was that the pharmacist filled a prescription for hydrocodone 4 days early and another prescription for hydrocodone 6 days early. The pharmacist was. Jul 3, - Unlike insurance, there are no early refill restrictions because you are paying the full discounted price yourself not your insurance company. If you filled your prescription at a large chain like Walgreens or CVS you can get a refill at any of their pharmacies nationwide as long as you stick within the same. Apr 3, - Because were I work, if you fill 2 oxycodone 30 mg rx's today, you will have of them tomorrow, and the next day the DEA will be knocking on your door. Having said that, all of you pharmacists who say "I don't have it" when you do have it are liars and are perpetuating the problem. You can be penalized. The individual practitioner must provide written instructions on each prescription indicating the earliest date on which a pharmacy may fill each prescription A. The rule does not stipulate how many separate prescriptions per schedule II controlled substance may be issued for the day supply. It is up to the practitioner to. Certified nurse practitioners and PAs can write prescriptions for C-II controlled substances if the following requirements have been met: .
