If used in psoriasis careful patient supervision is important. There is inadequate evidence of safety in human pregnancy. If a patient presents with symptoms such as blurred vision or other visual disturbances, the patient should be considered for referral to an ophthalmologist for evaluation of possible causes which may include cataract, glaucoma or rare diseases such as central serous chorioretinopathy CSCR which have been reported after use of systemic and topical corticosteroids. Use of a weaker corticosteroid is often advisable when there is a clinical improvement. There are no findings of relevance to the prescriber other than those mentioned elsewhere in the SPC.
