As with depression, drug choice in GAD should also be influenced by several other factors relating to the individual person, including their previous experience of treatments, likely drug interactions, safety and tolerability. If an antidepressant is indicated for an adult with depression, the NICE guideline on depression in adults recommends that it should normally be a selective serotonin reuptake inhibitor SSRI in generic form. In addition, the November edition of Drug Safety Update issued a reminder to test liver function before and during treatment with agomelatine. The NICE guideline on depression in adults recommends that dosulepin should not be prescribed for adults with depression because evidence supporting its tolerability relative to other antidepressants is outweighed by the increased cardiac risk and toxicity in overdose.
