Initially, there was an uproar because statin therapy was recommended for a larger proportion of the population, but the guidelines also recommended that some younger patients be removed from statin drugs. The FDA declared the recall of Lipitor generic by Ranbaxy as Class II, which signifies a remote chance of severe adverse consequences or death due to the product flaw. Atorvastatin can also interact with certain foods and with grapefruit or grapefruit juice. The recall is the latest in a series of problems to hit Ranbaxy, which has had all its factories in India stopped from sending drugs and ingredients to the United States, its biggest market. Last month, the FDA prohibited Ranbaxy from shipping to the United States any pharmaceutical ingredient made at its Toansa plant in northern Indian following an inspection that found poor manufacturing practices. Although substandard quality control issues can be alarming for the public, most US generic manufacturers can be trusted to produce equivalent generic substitutions due to regulatory oversight from FDA. Consumers can find the manufacturer listed on their prescription label or they can ask their pharmacist, and question if there has been recent recalls. In addition, many other manufacturers also make high-quality versions generic atorvastatin. Keep a list of them with you to show your doctor and pharmacist.
