Narcotic prescriptions can not be repeated. The total quantity of the prescription must be written. Pharmacists can only dispense. A complete filling of a prescription or a complete filling of a refill of a prescription does not occur until all the drug authorized by the practitioner has been provided. Thus, a prescription authorizing 30 dosage units is not deemed a complete filling or refilling until 30 dosage units have been dispensed, whether dispensed in.
