While the National Association of Pharmacy Regulatory Authorities provides recommendations on the scheduling of drugs for sale in Canada, each province may determine its own scheduling. The drug can be on the shelves like any other product. For example, many drugstores have moved products containing pseudoephedrine , an OTC product, into locations where customers must ask a pharmacist for them. An example of this is diphenhydramine Benadryl , an anti-histamine which once required a prescription but now is available OTC nearly everywhere. More recent examples are cimetidine and loratadine in the United States, and ibuprofen in Australia. No [POM], [P] or [GSL] products that are stocked in a pharmacy can be sold, dispensed, or pre-made until a responsible pharmacist is signed in and on the premises.
