By designating a single reference listed drug as the standard to which all generic versions must be shown to be bioequivalent, FDA hopes to avoid possible significant variations among generic drugs and their brand name counterpart. In the news release announcing the approval of generic versions of Cymbalta, the FDA stated, "Generic prescription drugs approved by the FDA have the same high quality and strength as brand-name drugs.
